

Well, what a year to be operating in a hospitality business. With continued Covid 19 lock downs, the addition of traffic lights etc and all the ups and downs associated with it, I believe the Clutha Licensing Trust area with its strong local base has come through well. We have had to take a long term approach to looking after our employees, balancing that with keeping the businesses running. We appreciate our excellent employees for working through this difficult time and I would like to take this opportunity to thank you all.

<u>Trading</u> – Covid Impacted trade starting with Lockdown 17<sup>th</sup> August 2021 moving into the new Traffic Light System with restrictions until 14<sup>th</sup> April 2022 when the limits, passes, and seated service were all removed. Trade still lifted compared to the year before as the community became familiar with our new system. Accommodation was up 19.34%, food sales was up 4.86% and liquor up 8.59%

<u>Management</u> – The White Horse Inn has benefitted from the staff being willing to step in and look after the business during a time of transition. On behalf of myself and the board, thank you.

**Board members** – This is the last meeting for the current board (9 members in a separate ward system), and as we move into a new structure with the Clutha District being one Ward (now 5 members at large), I would like to take this opportunity to thank each and every one for their time, input and resources they have put into the Clutha Licensing Trust.

<u>Property</u> – We sold the Oak Tree Inn on 7<sup>th</sup> June to local people, subsequently we then made the decision to demolish the Hotel South Otago. A huge thank you to the staff who worked through the transition of both businesses.

<u>Financial</u> – It disappoints me to advise that we are posting a loss before tax of \$(485,867). Our cash reserves at the end of the fiscal year were approximately \$1.7M. Plus \$0.5M on term investment. **Note:** a full set of accounts can be viewed on-line via the Trust's website: http://www.clt-trust.co.nz

<u>Gaming & Grants</u> - The machines operating within our facilities are operated on behalf of the Trusts Community Foundation. These machines deliver returns for both our business and to the community. <u>The Trusts Community Foundation Limited</u> - supported 46 groups and organisations within South Otago during the 2021/22 period to the value of \$455,406 (refer to the attached schedule of recipients)

<u>Community Support & Events</u> – The Clutha Licensing Trust distributed \$14,664 in sponsorships to various community groups within our district during the past year. This support allows the smaller events to keep happening in the community, such as school fairs, bowling tournaments and golf tournaments etc.

<u>Clutha District Senior Citizens Christmas Luncheons</u> – Due to the uncertainty with Lockdowns and a new Traffic Light system coming into place, we had to make the hard decision to cancel the Senior Citizens Christmas Luncheons for 2021. However, we still wanted to give to our community in some way, so we decided to advertise and encourage Senior Citizens to have a meal on us in the month of their birthday. This is open for a year from December 2021 and to date we have given meals at a cost of \$354.78 to the Clutha Licensing Trust. There is still time to take advantage of this offer.

#### THE TRUSTS COMMUNITY FOUNDATION GRANTS



The Trusts Community Foundation (TTCF) is the preferred gaming machine service provider for the **Clutha Licensing Trust** and operates its gaming machines at the following venues:

- Hotel South Otago, Balclutha
- Oak Tree Inn, Clinton
- Rosebank Lodge, Balclutha
- White Horse Inn, Milton

Management and staff at these outlets are acknowledged for providing their ongoing support to TTCF's class 4 gaming machine operation in such a diligent manner.

TTCF is authorised to operate class 4 gaming machines in licensed premises on a nationwide basis and has always had strong links with the Licensing Trust sector. The Foundation currently provides services to 8 individual Licensing/Charitable Trusts here in New Zealand and has always had a policy of distributing all pokie profits generated from venues within a Licensing Trust area directly back into the local community.

An amendment to the Gambling Act shortly after it came into force made provision for elected members of Licensing Trusts to have an input into TTCF's grants approval process by way of making recommendations to TTCF.

Accordingly, TTCF invites the elected members of the Clutha Licensing Trust to consider all compliant applications received from within the Clutha Trust boundaries on a monthly basis. TTCF subsequently considers these recommendations at their next scheduled Net Proceeds Committee meeting.


