TRUST PRESIDENT'S REPORT 2019



<u>Trading</u> – In the last financial year we have experienced extremely good results in accommodation with an increase of 16%, food sales increased slightly by 1.5 % with a slight decline in the combined liquor sales by just over 1%. This growth has come from increased tourism and increased commercial activity in the region.

Most of the Trusts premises exceeded our budgeted expectations, with Rosebank Lodge experiencing the largest sales growth and the best performance/profit return during this period.

The hospitality sector continues to change with accommodation and food sales increasing year on year, so our focus will remain on continued improvements in quality on what is on offer.

<u>Management</u> - During the 2018/19 year our long-standing General Manger resigned. The board appointed the Operations Manager and Office Manager in a joint interim position to take over the GM's role until a new GM could be appointed. On behalf of the board I would like to thank them for their efforts during this difficult period to keep things running smoothly.

In light of this the board have decided to put on hold the active consideration of sale of properties until the new management team have assessed all options available.

<u>Property</u> - The Trustees are focused on improving and updating our ageing properties to benefit the community and what they can offer.

During this period, we have sold the Bridge Tavern in Kaitangata and wish the new owners all the best.

<u>Financial</u> - I am very pleased to advise that the Trust has produced a "Black" bottom line for the second time in a good number of years. Our trading result before taxation was \$332,507 versus last year's profit of \$109,000.

We continue to look at our business model to see where we can make improvements and reduce costs. The annual increase/s to the adult wage will add further cost to our business and long-term these increases will impact on the price of goods to our customer.

Our cash reserves at the end of the fiscal year were approximately \$1.86M, which is up \$629K from last year, some of which is attributed to the sale of Bridge Tavern.

<u>The Trusts Community Foundation Limited</u> - supported 61 groups and organisations within South Otago during the 2018/19 period to the value of \$719,087 (refer to the attached schedule of recipients), compared with 53 applications during the previous period totalling \$689,016.

Community Support & Events:

The Clutha Licensing Trust distributed **\$15,948** in sponsorships to various community groups within our district during the past year. This support allows the smaller events to keep happening in the community, such as school fairs, bowling tournaments and golf tournaments etc.

- Otago Shearing Competition in February 2019
- South Otago Sports Award in February 2019

<u>Clutha District Senior Citizens Christmas Luncheons</u> – The Trust again hosted our very popular annual Senior Citizens Christmas luncheons in early December at the Rosebank Lodge, and we are planning this event for mid-December again this year. On entry our guests make a small donation and last year this totalled **\$1,430.00** over the two days, which was donated to the Clutha District LandSAR.


